The amount of contribution assessed by the assessing authority on best judgment basis for the years 2019-2020 to 2023-2024 is at Rs.1,67,505.00/-The appellant has paid an amount of Rs.56000/ - towards the 1/3 rd of the disputed amount as provided under the Kerala State Waqf Rules 2019. The appellant had averred in the appeal memorandum that the Committee is not having any income to pay the contribution amount fixed by the Board. Hence they pray for setting aside the assessment order passed by the assessing authority. The appellant has submitted return for the disputed year along with the appeal.

On verification of the office records it is seen that the best judgment assessment order for the disputed years were issued to the appellant since no return was submitted before the assessing authority at appropriate time even after receipt of the show cause notice issued by the assessing authority. Even though the notice issued by the assessing authority has been received and no return was submitted by the appellant, the Board feels that a lenient view can be taken in the case of assessment of the above Waqf.

Hence the above appeal has been remanded back to the assessing authority for a fresh disposal and the assessing authority is directed to re-assess the accounts of the Waqf for the appeal period in accordance with the Act, Rules and Regulations after considering the returns submitted along with the appeal memorandum. If the assessing authority is not satisfied with the accounts submitted along with this appeal, the authority is free to call for the supporting books and documents. The appellant is further directed to submit the true and correct statement of accounts before the Board in time.

The above appeal is disposed with the above direction.
