## 1. OP No. 220/2023 Manjalloor Kundayam Hanafi Muslim Jama-ath, Kollam

The present Original Petition is filed under Sections 32, 46, 47 and 48 of the Waqf Act, 1995 read with Section 26 of the Code of Civil Procedure seeking cancellation of the declaration made by the 2nd respondent dated 07.05.2023 expelling the petitioners from the Jama-ath Paripalana Samithi and for their reinstatement to the respective posts.

The petitioners have contended that they were duly elected by the General Body of the Jama-ath on 02.10.2022 as General Secretary, Vice President, Joint Secretary and Committee Member respectively, and that their removal by the proceedings dated 07.05.2023 was arbitrary, illegal and contrary to law. It is their case that no notice was issued to them prior to the decision of expulsion and that the General Body had not authorised such removal. On the other hand, the respondents filed a counter alleging ideological deviation by the petitioners but failed to substantiate the same by evidence. Despite filing a counter, the respondents remained absent continuously after 03.10.2024 and the matter was heard ex parte.

On consideration of the pleadings, evidence and records, this Board is of the view that the action of the respondents in expelling the petitioners suffers from serious legal infirmity. Firstly, it is a settled principle of law that any action affecting civil rights must conform to the rule of *audi alteram partem*, the fundamental canon of natural justice. The records show that no notice or opportunity of hearing was given to the petitioners before passing the impugned order of removal dated 07.05.2023. Secondly, under the scheme of the Waqf Act, 1995, particularly Sections 32 and 47, the Board has supervisory control to ensure that waqf institutions are administered in accordance with law and their bye-laws. Removal of elected office bearers, being a serious matter affecting representation of the Jama-ath, must be carried out strictly in accordance with the bye-law and upon proper resolution of the General Body. No such resolution has been produced before this Board, nor is there any material to show compliance with the bye-laws.

Thirdly, this Board had in I.A. No. 201/2023 specifically restrained the respondents from appointing others in the posts held by the petitioners and from conducting meetings without their participation. Any action taken in violation of such interim order is void and cannot be recognised in law. The respondents' conduct in removing the petitioners during the pendency of this O.P., in derogation of the Board's order, renders the impugned proceedings doubly illegal.

In the absence of cogent evidence from the respondents and in the face of admitted violation of natural justice, the expulsion dated 07.05.2023 cannot be sustained. Accordingly, the declaration issued by the 2nd respondent expelling the petitioners is hereby set aside. The petitioners are reinstated to their respective posts as elected office bearers of the Jama-ath Paripalana Samithi. It is further directed that any appointments or decisions taken contrary to this order stand annulled. The respondents are cautioned that any further obstruction of the petitioners in functioning as office bearers will invite proceedings under the Waqf Act, 1995 for violation of binding orders of this Board.

This O.P. is thus allowed. No order as to costs.

The petitioner had filed this Original Petition under Sections 32, 69 and 70 of the Waqf Act, 1995, seeking orders for appointing a receiver to take over the administration of the 1st respondent institution, Sayed Usman Sahib Memorial Madrassa Nooru Ul Islam Association, and further seeking a direction to conduct free and fair election to the Association in accordance with its bye-laws. The case of the petitioner is that he is a member and legal heir of Sayed Usman Sahib Memorial Madrassa Masjid and Noor-ul Islam Association. He alleged that the 2nd respondent has usurped the office of Secretary without any legal authority, that no general body has been convened since 2018, that proper accounts have not been maintained for more than six years, and that waqf funds are being misused for personal purposes.

The respondents entered appearance and opposed the petition, contending that the petition is not maintainable either on facts or in law. It was specifically argued that the Board has no jurisdiction to appoint a "receiver" for any waqf and that Section 63 of the Waqf Act, which permits appointment of a mutawalli under certain circumstances, is not attracted to the present case. They further submitted that the allegations raised by the petitioner are false, that the petitioner's claim of being a member and heir is unsubstantiated, and that valid elections were held in the jama-ath. They denied any misappropriation of funds and maintained that accounts are properly kept.

The petitioner filed a proof affidavit reiterating his allegations but failed to produce any proper evidence to substantiate the same. Though an Advocate Commissioner was appointed to record witness evidence, the materials placed on record were photocopies which cannot be admitted on evidence.

On a careful consideration of the pleadings, materials, and submissions, this Board finds that the relief of appointing a receiver is wholly beyond the scope of the powers conferred on the Waqf Board under the Waqf Act, 1995. The concept of a receiver arises under the Code of Civil Procedure and cannot be invoked before this Board unless specifically provided for under the tatute. Neither Section 32. nor Sections 69 and 70 of the Waqf Act, authorise the

Board to appoint a receiver. Section 63 of the Act deals with appointment of a mutaivalli in limited circumstances, which are not made out here. Hence, the principal relief sought in the petition is legally unsustainable. With respect to the allegations of mismanagement and misuse of funds, the petitioner has not adduced cogent or admissible evidence to prove the same. His status as member or heir has not been established. The allegation that there has been no election since 2018 is also not proved. Allegations of misappropriation remain mere assertions unsupported by documentary or oral evidence. In such circumstances, this Board is unable to accept the petitioner's version or to interfere in the administration of the waqf. In the result, the Board holds that the Original Petition is devoid of merit. The reliefs sought are not maintainable, and the petitioner has failed to prove the allegations raised. These three Original Petitions were filed before the Board relating to the governance, administration, and electoral process of the Valiya Palli Muslim Jama-ath, Thiruvananthapuram. O.P. No. 118/2023 was instituted under Sections 32, 47, 70, and 71 of the Waqf Act, 1995, praying for an enquiry into the Jama-ath's administration, restraint of presidential-style elections, conduct of fair elections through a Returning Officer, and audit of accounts. O.P. Nos. 184/2023 and 196/2023 raised connected prayers regarding the management and elections of the Jama-ath. Considering the overlapping issues, all three petitions were consolidated for joint trial, with O.P. No. 184/2023 treated as the lead case.

On 12.06.2025, a compromise petition (I.A. No. 219/2025) was filed jointly by the petitioners and respondents in O.P. No. 184/2023, recording mutually agreed terms including (i) resignation of the existing committee, (ii) formation of an ad-hoc committee, (iii) conducting of elections on a ward-wise ballot basis, and (iv) withdrawal of all pending cases. It is noted that all parties to the consolidated proceedings have accepted the compromise, save for the 2nd petitioner in O.P. No. 118/2023, who had sought some time for expressing opinion. The 1st petitioner in O.P. No. 118/2023 has already signified consent to withdraw, and all other petitioners and respondents are agreeable to the terms of settlement.

The Board has examined the compromise in the light of the reliefs sought in the petitions. The substantive prayers of the petitions particularly the demand for fair elections, proper governance, and audit of accounts are effectively satisfied through the settlement. Under Order II Rule 3 and Order XXIII Rule 3 CPC, once matters are consolidated for joint trial, common issues may be adjudicated or disposed of together. A valid and lawful compromise in the lead case can be extended mutatis mutandis to the connected petitions, where it substantially addresses the grievances raised therein. The fact that

one of the petitioners has withheld consent does not, by itself, defeat the settlement, provided that the compromise is not unlawful, does not prejudice their legal rights, and promotes the overall interest of the Jama-ath.

This Board is of the considered view that the compromise satisfies the core objectives of the petitions and is in the broader interest of maintaining peace and harmony in the mahal community. The dissent of the 2nd petitioner in O.P. No. 118/2023 is duly recorded; however, since no specific prejudice is caused to their rights and liberty is reserved to approach the Board independently for redressal of any surviving grievance, the compromise is binding and enforceable across the consolidated proceedings.

Accordingly, I.A. No. 219/2025 is accepted and recorded as a valid settlement. O.P. Nos. 196/2023, 184/2023, and 118/2023 are treated as closed in terms of the compromise. Liberty is reserved to the 2nd petitioner in O.P. No. 118/2023 to seek appropriate remedies before the Board in the event of any subsisting or fresh grievance.
