	The Petitioners have filed this Original Petition under Sections 32, 61, 67, 68 and 70
	of the Waqf Act, 1995, seeking, inter alia, appointment of an auditor for auditing the
	accounts of the 1st respondent Jama-ath for the period 2018–2022, recovery of loss
	if any sustained by the waqf from those responsible and initiation of prosecution
	against them, appointment of an Executive Officer from among the office bearers of
	the Board to administer the waqf and its funds, and other consequential reliefs.
	During the pendency of the OP, the petitioners had moved I.A. No. 144/2022
	for appointment of an auditor, which was allowed, and the Divisional Waqf Officer,
	Manjeri was directed to appoint an auditor. In compliance, one Mr. Ismail, empanelled

auditor, was appointed and he submitted his audit report dated 19.01.2023. Thereafter, the petitioners filed I.A. No. 192/2023 seeking to set aside the audit report and for appointment of a fresh auditor, alleging that the report was incomplete and flawed. The respondents filed a detailed counter contending that the entire receipts and account books had been produced, that the auditor had verified the records and submitted an impartial report, and therefore the prayer for re-audit is untenable.

The Board, after hearing, by order dated 07.12.2024 directed the auditor to submit his explanation with respect to the allegations. The auditor has since submitted his explanation along with documents, wherein he has candidly admitted that he had verified the accounts only randomly and has further expressed his inability to conduct proper audit on account of his age and health. Thus, the very auditor who submitted the earlier report has admitted that the audit was incomplete and has requested that another auditor may be appointed in his place.

In view of the said admission and considering the interest of transparency and better administration of the waqf, the Board is of the considered opinion that the audit already filed cannot be relied upon and that a fresh audit is warranted. The prayer of the petitioners for proper audit therefore deserves to be allowed, while the other reliefs sought for in the main OP can be addressed based on the outcome of the audit.

Accordingly, the following directions are issued:

- 1. **Fresh Audit:** The Divisional Waqf Officer, Malappuram is directed to appoint a suitable empanelled auditor to conduct a comprehensive audit of the accounts of the 1st respondent Jama-ath for the period 2018–2022.
- 2. **Objections/Explanations:** After completion of the audit, the report shall be submitted to the Divisional Waqf Officer and he shall call for explanations and objections, if any, from the Jama-ath committee with respect to the findings of the audit. The Divisional Waqf Officer shall issue necessary directions for

curing the defects and irregularities, if any, pointed out in the audit.

- 3. **Recovery:** If the auditor certifies that any loss has been caused to the waqf and any amount is liable to be recovered from any person, the Divisional Waqf Officer shall place the matter before the Board through the administrative side for appropriate orders under the Act.
- 4. **Executive Officer:** At present, there is no material warranting appointment of an Executive Officer. However, the Board reserves liberty to invoke its powers under Section 38 of the Act in future, if it is found necessary on the basis of the audit report or subsequent findings that the committee has acted prejudicially to the interests of the waqf.

With these directions, the Original Petition and connected interlocutory applications stand disposed of.

8 OP 3/2025-Malappuram Dist-Irumbiliyam Irshadul Musimeen Sangham Vendalloor Mahallu Committee

The above Original Petition has been filed by the petitioner seeking directions to restrain the 2nd respondent–Returning Officer from proceeding with the election of *Irshadul Muslimeen Sangham* scheduled on 19.01.2025, and further to direct acceptance of his nomination and to permit him to contest in the said election. Notice was duly served on both respondents. The 1st respondent entered appearance through Adv. Zafarulla, and the 2nd respondent–Returning Officer was personally present before the Board. After hearing, the matter was posted for orders.

It is noted that as per the order dated 04.03.2024 in I.A. No. 406/2022 in O.P. No. 63/2021, this Board had appointed the 2nd respondent, Adv. Mohammed Thoyyib Hudavi, as Returning Officer to conduct the election of the Jama-ath, with directions to follow all procedural formalities. In compliance, the Returning Officer conducted the election and, on 27.01.2025, submitted his report before the Board stating that the election has been duly completed. Consequently, O.P. No. 63/2021 was closed based

	on the Returning Officer's report.
