ordinarily be allowed if it is required for determining the real question in controversy between the parties, provided it does not cause injustice or prejudice to the opposite side.

In the present case, the proposed amendment does not alter the fundamental nature or scope of the reliefs sought in the original petition. It is also noted that the matter is still at the initial stage and the respondents will have full opportunity to meet the amended pleadings. No prejudice which cannot be compensated by costs has been demonstrated.

In these circumstances, the Board is satisfied that the amendment is bona fide and necessary for the proper disposal of the matter. Accordingly, the amendment petition is allowed. The petitioner shall carry out the amendment in the original petition within ten days from the date of this order. The respondents may file additional counter, if any, within thirty days thereafter.

### IA 18/2025:-

I.A. 18/2025 seeks audit of the accounts of Nusrathul Islam Sangam for 2010-11 to 2018-19, alleging misappropriation and relying on the Advocate Commissioner's report. The respondents oppose, pointing out that by order dated 16.12.2024 in I.A. 627/2024, audit has already been directed for 2019-20 to 2023-24, and that the present request is an attempt to expand that order through a separate proceeding.

The earlier order stands unmodified and binds the parties. Any enlargement of its scope must be sought in that proceeding by review or appeal, not by filing a fresh I.A. This application is therefore not maintainable. Further, no concrete material has been shown to justify a special audit reaching back to 2010; the Commissioner's report is not an audit and cannot substitute the statutory process.

Ordering an additional decade-long audit at this stage would delay the main O.P. and duplicate the present audit. The ongoing audit for 2019-2024 can still flag prior-year irregularities, in which case the petitioners may seek appropriate relief in I.A. 627/2024.

I.A. 18/2025 is dismissed without prejudice to such liberty. The respondents shall cooperate with the audit already ordered and preserve all records for 2010-2019 for production if required.

#### IA 19/2025:-

This I.A. is filed by the petitioner in O.P. under Sections 32, 47, and 63 of the Waqf Act, seeking production of the minutes book of Nusrathul Islam Sangam for the last 14 years from the period 2010 onwards. The request is based on the Advocate Commissioner's report in I.A. 626/2024, which recorded serious irregularities in the affairs of the respondent society, including alleged tampering of the minutes book.

The respondents oppose, contending that the petition is not maintainable, that earlier orders limited audit to five years, and that the Commissioner was not authorised to examine records. They also point to pending steps to set aside the Commission report.

On perusal, the relief sought is only for production of a primary record—the minutes book—which is under the custody of the respondents. The petitioner's prayer does not amount to an order for audit beyond any prescribed period but seeks a document directly relevant to the issues in the O.P., including the allegation of non-conduct of elections for over a decade. The Waqf Board, under Sections 32 and 33 of the Act, has the power to call for and inspect such records, and production at this stage will assist in a complete and fair adjudication. Objections as to authenticity or relevance can be raised when the document is tendered in evidence.

In the result, I.A. 19/2025 is allowed. The respondents shall produce the minutes book of Nusrathul Islam Sangam for the period 2010 to date within one month.

OP-23/2022- KannurDist.-Puthiyangadi Muslim Jama-ath Committee Order pronounced in IA 210/2025 & IA 211/2025 vide separate order sheet.

## IA 210/2025

The petitioner seeks to be impleaded as supplemental 7th respondent in this Original Petition concerning allegations of financial irregularities in the Puthiyangadi Muslim Jamaath Committee and its sub-committees. He claims that he is the present Secretary of the Committee, having assumed charge on 21.02.2025, and seeks to adduce evidence and mark documents if he is impleaded in this proceedings.

The respondents oppose impleadment, citing lack of proof of the 2nd

respondent's inability to depose, alleged involvement of the applicant in earlier irregularities, and ineligibility to hold office.

It is undisputed that the applicant is the current custodian of the Committee's records and competent to speak to its present affairs. Allowing the application will facilitate complete adjudication and prevent multiplicity of proceedings; any prejudice can be addressed through cross-examination.

In the result, I.A. No. 210/2025 is allowed. The applicant is impleaded as supplemental 7th respondent in this proceedings. The officer is directed to amend the cause title on the basis of this order.

#### IA 211/2025:-

I.A. 211/2025 is filed by the  $2^{nd}$  respondent to reopen the evidence for the respondents in O.P. under Sections 32, 38, 61, 64(g)(i)(k), 69, and 70 of the Waqf Act . The petitioner submitted that the evidence is to be re-opened for examination of the present Secretary, Suhail, and marking of documents.

It is not disputed that Suhail is the present Secretary and custodian of the Committee's records. Objections as to his eligibility or past conduct are matters for separate determination and do not preclude his examination for the limited evidentiary purpose. Any prejudice to the other side can be addressed by cross-examination and contesting admissibility.

In the result, the petition is allowed on payment of costs of  $\square$  2,000 $\not$  to the respondents herein. Evidence is reopened for the limited purpose of examining Suhail and marking connected documents. Respondents are at liberty to cross-examine and raise objections.

EP 1547/2020/KSGD-KasaragodeDist-Kasaragode Taluk-MuhiyudheenJuma Masjid Order pronounced vide separate order sheet in IA 102/2024.Posted to 28/10/2025.

The present I.A. No. 102/2024 is filed by the petitioner in the above enquiry proceedings seeking to implead Sri. Muhammed Haneefa, the present President of the committee, as additional 4th party to the proceedings.

The petitioner contends that the committee in question was elected pursuant to the order of the Board in O.P. No. 153/2019, through an election conducted by the Returning Officer appointed by the Board. It is stated that due to the resignation of the former President, Sri. K.H. Ashraf, on account of ill health, Sri. Muhammed Haneefa,

who was then Vice President, has assumed the office of President with the unanimous approval of the committee.

The respondent has opposed the application, contending that he is the Muthawalli of the waqf by virtue of the order of the Hon'ble Waqf Tribunal in O.S. No. 70/2020 dated 30.07.2021, and that the committee has no authority to interfere in the administration of the waqf. It is further contended that the dispute regarding the committee and Muthawalli is still pending before this Board.

On consideration, this Board finds that the subject matter of the enquiry relates to the administration and management of the waqf, including issues connected with the committee. In such circumstances, any person who is presently claiming to hold the position of President of the committee, and whose role may be directly affected by the outcome of the proceedings, is a proper and necessary party for effective adjudication. The impleadment would enable the Board to have before it all persons who may be directly concerned with the subject matter, thereby avoiding multiplicity of proceedings and ensuring that the decision is binding on all concerned.

The objections raised by the respondent as to the legitimacy of the committee or the President are matters to be decided on merits in the main proceedings and are not grounds to reject impleadment at this stage.

Accordingly, I.A. No. 102/2024 is **allowed**. Sri. Muhammed Haneefa is impleaded as additional 4th respondent in the above enquiry proceedings. The petitioner shall carry out necessary amendments in the cause title within **7 days**.
