1.	<p data-bbox="263 293 1244 338">OP No. 106/2022 Noor Muhammadiya Jama-ath, Idukky</p> <ol style="list-style-type: none"><li data-bbox="311 383 1433 808">1. The petition has been filed by a member and alleged beneficiary of the Nedumkandam Noor Muhammadiya Jama-ath, seeking an audit of the Waqf's accounts for the past five years, with particular reference to the mosque reconstruction undertaken in 2016. The petitioner alleges financial mismanagement and lack of transparency in the administration of the Waqf Committee, and further seeks action against those responsible for any irregularities found during such audit.</li><li data-bbox="311 819 1433 1200">2. The respondent Waqf Committee has filed a detailed counter. The respondents primarily question the locus standi of the petitioner, asserting that he is not a bona fide member or recognized beneficiary of the Waqf. It is also submitted that the petitioner has a history of filing vexatious complaints before various forums against the committee and the imam, which raises serious doubts regarding the bona fides of the present complaint.</li><li data-bbox="311 1211 1433 1592">3. It is further submitted by the respondent committee that all accounts and statements have been duly submitted to the Waqf Board in accordance with the provisions of the Waqf Act, 1995 and relevant rules. The respondent committee has taken the stand that the financial dealings of the Waqf are transparent, and that the Waqf Board has never raised any objection or issued any adverse finding against the committee with respect to compliance.</li><li data-bbox="311 1603 1433 1984">4. Upon perusal of the file, it is noted that the mosque reconstruction took place in the year 2016, whereas the present petition was filed only in 2022, without furnishing any reasonable explanation for the inordinate delay of six years. The petition does not disclose any exceptional circumstance that would justify condonation of delay or extend the period of limitation under any equitable or statutory ground.</li><li data-bbox="311 1995 1433 2040">5. The Board had, for the purpose of gathering evidence,</li></ol>

appointed Adv. Mohammed Favas as Advocate Commissioner on 14/09/2023. The Advocate Commissioner filed an interim report on 24/01/2024, after completing the petitioner's side of evidence. However, it is crucial to note that the petitioner failed to mark any documents to substantiate the allegations raised. The entire case rests on unsubstantiated assertions, lacking material particulars, including even the quantum of misappropriated funds allegedly involved.

6. On the other hand, although the respondent committee did not step into the witness box, they sought to mark documents 1 to 10 in support of their position. The petitioner has not made any effort to rebut these documents or to demonstrate their inadequacy or falsity.
7. It is also pertinent to consider that no other members of the Jama-ath have come forward to support the petitioner's version. The allegations thus appear to be based solely on the petitioner's perception, lacking community support or corroboration. This further suggests that the petition may have been filed based on individual grievance, rather than on a genuine concern arising from collective interests of the beneficiaries of the Waqf.
8. The Waqf Board is vested with supervisory jurisdiction under the Waqf Act, 1995, particularly under Sections 33, 35, and 64. However, before invoking these provisions, there must be prima facie material or substantiated evidence pointing to mismanagement or misappropriation of funds. Mere allegations, especially when stale, unsupported, and lacking in specificity, cannot form the basis for invoking such drastic action.
9. In the instant case, no cogent evidence has been produced to substantiate the alleged mismanagement. The petition lacks documentary proof, fails to identify the specific loss or irregularity, and is hit by unexplained delay. The evidence presented is wholly inadequate to warrant any direction for further audit or initiation of action under the Waqf Act. In light of the above facts and legal analysis, the petition is

	<p>found to be devoid of merit. The allegations remain unsubstantiated, the delay remains unexplained, and the petitioner has failed to establish locus standi or a prima facie case warranting interference by the Board. Accordingly, the petition is hereby dismissed.</p>

The respondent, in their reply, submitted that the <b>Divisional Waqf Officer does not have statutory powers to independently conduct land surveys</b>. Upon consideration of the submissions and records, the Board notes that there are <b>allegations of encroachment affecting the boundaries</b> of the waqf land in question. In such circumstances, it is necessary and appropriate to obtain a <b>clear factual position regarding the boundaries and extent of the waqf property</b>.</p> <p>While the prayer to direct the Divisional Waqf Officer for direct survey <b>cannot be allowed in its present form</b>, the Board finds merit in the request to ascertain the actual status of the land and boundary line. Hence, in the interest of justice and to facilitate fair adjudication, the Board hereby appoints <b>Adv. Shifa S. Rawther as Advocate Commissioner</b> to conduct a survey of the <b>waqf property owned by Kaduvinal Muslim Jama-ath</b> with the <b>assistance of a qualified licensed surveyor</b>.</p> <p>The Advocate Commissioner shall visit the site, supervise the measurement,</p>

	<p>and submit a <b>detailed report</b> regarding the boundaries, extent, encroachments (if any), and present status of the property. The <b>petitioner shall pay an initial batta of ₹ 7,000/-</b> to the Advocate Commissioner, in addition to bearing the <b>actual cost of engaging the surveyor</b>. The Advocate Commissioner shall complete the task file her report before the Board at the earliest.</p>
