The petitioner, Smt. Faseeha Beegam, was originally a member of the Kattumurakkal Muslim Jama-ath and later became a member of Poothayam Jama-ath after marriage. Following her divorce, she obtained viduthal (release certificate) from Poothayam Jama-ath and applied on 16.05.2019 for membership in her original Jama-ath along with her two dependent children. The petitioner produced before this Board the earlier orders of Divisional Office, Thriruvanathapuram, dated 26.09.2023 and 20.05.2025 directing the Kattumurakkal Jama-ath to grant her and her children permanent membership without collecting any fee. The materials show that despite clear and binding orders of the Board, the respondents have failed to comply and have refused to issue membership confirmation, causing continued hardship and injustice to the petitioner. Notices were served on the respondents, but none of them entered appearance or offered any explanation, As the respondents have chosen to remain absent

without justification, the Board accepts the petitioner's case. Accordingly, this petition is allowed ex parte, and the President and Secretary of Kattumurakkal Muslim Jama-ath are directed to grant permanent membership to Smt. Faseeha Beegam and her dependent children, Amjath Ali and Ameer Ali, without charging any fee, and to issue written confirmation and report compliance to the Board within 30 days of the date of receipt of this order. The petitioner, who was the 3rd respondent in O.P. No. 130/2022, has filed this I.A. No. 116/2025 seeking to set aside the ex parte order dated 11.06.2024 passed by this Board in the above O.P. The petitioner contends that he had no notice of the proceedings before the Board, that he was aged and ill, and that he could not present objections to the audit findings.

The 3rd & 4th respondents have filed detailed objections strongly opposing the I.A., that the petitioner was Secretary of the Jama-ath from 2016–2022. All proceedings in O.P. 130/2022, including IA 152/2022 for audit, were well within his knowledge, and he had participated in related High Court proceedings in O.P. (Wakf) 31/2022, filed in his capacity as Secretary. Audit was completed on 31.10.2022, showing a loss of □ 27,12,504/-.Notices were issued by the Divisional Waqf Officer after the Board's order dated 11.06.2024, but neither the petitioner nor other responsible persons filed objections. The present I.A. is filed after a delay of more than 9 months, with no petition for condoning delay. The purpose of the I.A. is only to delay the recovery proceedings initiated as per the audit report.

After hearing parties and perusing the records, the Board finds that the petitioner was fully aware of the proceedings in O.P. 130/2022. His participation in High Court litigation connected with the same OP conclusively establishes notice and knowledge. The ex parte order dated 11.06.2024 was passed only after granting sufficient opportunities. No acceptable explanation is offered for non-appearance, nor for the inordinate delay of 9 months in filing this I.A. The petitioner has not filed any application for condonation of delay, which makes the I.A. not maintainable.

The High Court in W.P.(C) No. 46226/2024 permitted the petitioner to file an application for recall, but did not direct this Board to recall the order. The High Court specifically directed that the Board may consider the application uninfluenced, which this Board has now done.

The petitioner's grievance regarding lack of opportunity to respond to the audit report can be addressed by the Divisional Waqf Officer within the execution of the original directions, and does not require setting aside the entire ex parte order. The order dated 11.06.2024 was passed to safeguard the Waqf property, based on a statutory audit pointing to a loss of \Box 27,12,504/, and requires urgent implementation, which has been delayed due to the present I.A.

The petitioner has not shown any sufficient cause to set aside the ex parte order. The application is highly belated, defective, and appears intended to delay recovery from persons responsible for loss caused to the Waqf. I.A. No. 116/2025 is hereby dismissed. The ex parte order dated 11.06.2024 in O.P. No. 130/2022 shall stand confirmed.

This Interlocutory Application is filed by the respondents in O.P. No. 220/2023 seeking to set aside the ex-parte order dated 21.08.2025 passed in the Original Petition. The petitioners herein contend that although they had filed objections in the O.P. on 14.02.2024, they were set ex-parte due to lack of notice of the subsequent posting dates, and because they believed that further proceedings would be taken up only after disposal of W.P.(C) No. 38750/2024 pending before the Hon'ble High Court. They also assert that they have substantial grounds to contest the matter on merits.

The respondents herein have filed a detailed counter statement opposing the application. They contend that the petitioners were aware of the proceedings and that the ex-parte order has already been implemented by the Jama-ath, and therefore the application is not maintainable.

The records show that the petitioners had earlier entered appearance and filed objections. It is also noted that after the order dated 03.10.2024 in I.A. 201/2023, no fresh posting date was shown in the order, and the petitioners'

contention that they were unaware of the subsequent posting appears plausible. Considering the nature of the dispute and the necessity of hearing all affected parties for a proper adjudication, this Board is of the view that the petitioners should be given an opportunity to contest the matter on merits.

Accordingly, I.A. No. 391/2025 is allowed. The ex-parte order dated 21.08.2025 in O.P. No. 220/2023 is hereby set aside, subject to the petitioners paying costs of Rs. 2,000/- to the respondents within 15 days. On payment of costs, the matter shall stand restored to file and posted for further proceedings.

 The Interlocutory Application filed by the Parent Teachers Association (PTA) of Khaderiya High School Kottukad represented by its President Sri

of Khaderiya High School, Kottukad, represented by its President, Sri. Noushad A., seeks to implead the PTA as an additional 6th respondent in O.P. No. 166/2025.

The applicant contends that the subject matter of the Original Petition relates to issues concerning the management and proposed demolition and reconstruction of the school building of Khaderiya High School, which directly affects the students, parents, teachers, and the school community. The PTA, being a statutory body recognized under the Kerala Education Rules, is vitally interested in safeguarding the welfare, safety, and educational rights of the students. It is further stated that the existing school building has been assessed as structurally unsafe and that the PTA has taken active part in the decision-making process regarding the reconstruction and has resolved to participate in the proceedings. A resolution dated 06.10.2025 authorizing its President to represent the PTA has also been produced.

Having considered the averments in the affidavit and materials placed on record, this Board is of the view that the presence of the PTA, a stakeholder representing parents, teachers, and students of the school, is necessary for the complete and effective adjudication of the issues involved in O.P. No. 166/2025...

In the above circumstances, the Interlocutory Application is allowed. Sri. Noushad A., President, Parent Teachers Association (PTA), Khaderiya High School, Kottukad, is hereby impleaded as additional 6th respondent in O.P. No. 166/2025. Posted to 20.01.2026

This petition/Complaint has been filed by Sri. Shahul Hameed Thannippara, father of late Nasarudheen, alleging that the Pezhumoodu Puthenpally Muslim Jamaath Committee removed the Meezan stone placed on the grave of his deceased son without proper authority and in violation of established procedure.

The complainant contends that the Meezan stone erected was within permissible limits and that its removal caused mental distress and amounted to arbitrary action on the part of the Committee. The Committee, in its statement, admits that the stone was removed by the Committee on 27/12/2024, pursuant to a decision taken in an emergency meeting. It is also admitted that no prior written show-cause notice or opportunity of hearing was given to the petitioner before taking such action.

The Board has examined the petition, the documents produced, the statements of both sides, and the enquiry report of the Board's representative. In the enquiry report of the officer of the Board it is clearly stated that Meezan stone with names inscribed was seen in the Khabar of about 3 persons in the Khabarsthan. The Chairman of the advisory Board admitted that the removal of the meezan stone was willful. It is evident that the removal of the Meezan stone was carried out unilaterally by the Committee. The Committee failed to issue a formal written notice and did not provide the complainant an opportunity to present his explanation, which is required under principles of natural justice. Even in matters relating to graveyard management, proportionality, fairness, and due process are expected from the Jama-ath Committee.

The Board is of the view that while the Jama-ath Committee may regulate the nature and dimensions of Meezan stones in accordance with its Byelaws, the complainant cannot be deprived of a permissible and modest Meezan stone and unilateral removal without due procedure cannot be justified. In view of the above findings, the Board hereby orders as follows:

The Perumoodu Puthenpally Muslim Jamaath Committee shall reconstruct and reinstall a Meezan stone on the grave of late Nasarudheen, of similar material, and design as existed prior to its removal. The size of the stone shall not be less than normal meezan stone.
