The petitioners contend that the election held on 16.05.2025 was conducted in violation of the mandatory procedure prescribed by the 2007 bye-law and that a duly constituted three-member Election Committee was not formed; they further contend that the notice dated 09.05.2025 was insufficient and that various irregularities are alleged in the conduct of the election. The respondents have not, at this stage, placed any material on record by way of counter-affidavit to rebut these allegations. 2. It is, however, apparent from the material before the Board that **no** clear evidence has been placed on record to show whether the newly elected committee has already taken over charge of the Jama-ath. In the absence of this crucial factual position, an immediate coercive order restraining the committee from "taking charge" may be impracticable and may give rise to unnecessary administrative and practical complications, including the risk of rendering any interim direction unworkable. 3. In the circumstances, and having regard to the need to preserve the rights of the parties as well as to protect the day-to-day administration of the Waqf, this Board directs as follows: (a) The Board hereby **defers** consideration of the prayer for a prohibitory interim order in I.A. No.163/2025 and declines, at this stage, to pass any order restraining the newly elected committee from taking charge. This is without prejudice to the right of the petitioners to urge appropriate interim relief after factual verification.

- (b) The Divisional Waqf Officer, Thrissur, is directed to submit a factual report on the following points after necessary local verification and enquiries: (i) whether, as a matter of fact, the newly elected committee has taken charge and, if so, the exact date and manner of handing over; (ii) whether the election held on 16.05.2025 complied with the relevant provisions of the 2007 bye-law, particularly in regard to constitution of the Election Committee, notice nomination and scrutiny procedures, requirements, representation and other mandatory formalities; and (iii) any other relevant facts touching upon the regularity and propriety of the election process. The Divisional Waqf Officer shall also collect and place on record copies of the election notice, voters list (if any), nomination papers and their scrutiny record, minutes of any meeting called for election, and any documents available with the Jama-ath relating to handing over of charge.
- (c) The Divisional Waqf Officer shall file the factual report with the Board within **thirty** (30) days from the date of receipt of this order.
- 4. Until the factual report is received and the matter is listed for further consideration, the parties are directed to **maintain peace** and **not to take any action which would alter the position of the Jama-ath or its assets irreversibly**. List I.A. No.163/2025 along with the main petition for further consideration after receiving report.

5. OP No. 42/2025 Kaipparamb Muslim Jama-ath, Thrissur Order passed vide separate sheet

1. The above Original Petition has been filed under Section 32 of the Waqf Act, 1995, seeking an inquiry into the administration and affairs of the Kaiparambu Juma-ath Committee and into the alleged actions undertaken by the present Committee in violation of the governing bye-laws. The petitioners further seek to cancel the decision taken by the 1st respondent-Committee suspending them from the Mahal without convening a General Body meeting, to restore their membership along with all attendant privileges, to direct the

- Committee to convene a General Body meeting under the supervision of an Observer appointed by the Board, to take necessary prosecution steps against the Committee, and for other consequential reliefs. The petitioners are the former Secretary and President of the Committee for the period 2019–2024 and allege that the present Committee is acting out of animosity toward them.
- 2. The petitioners had earlier filed I.A. No. 43/2025, wherein this Board passed an interim order staying the suspension of the petitioners from the Jama-ath and directing the respondents to continue extending all services and privileges to them until further orders. The respondents subsequently entered appearance and filed objections, strongly opposing the reliefs sought in the O.P. According to them, the petitioners, during their tenure as office bearers, were responsible for serious malpractices in handling the accounts of the Waqf, leading to substantial financial loss. They pray for dismissal of the petition and seek directions to compel the petitioners to hand over all accounts, receipts, vouchers and related documents pertaining to the period 2019–2024, including the records relating to the construction of the new Madrassa. They also seek an order directing the petitioners to remit an amount of Rs. 3,20,000/-, as reflected in the audit report prepared by Jeeson & Company, Chartered Accountants, dated 31.01.2025, and urge the Board to initiate prosecution proceedings against the petitioners for alleged acts detrimental to the Waqf.
- 3. The matter was referred for mediation by the Board in an attempt to amicably resolve the dispute. However, no settlement was reached, and as neither party adduced oral evidence, the matter was posted for orders based on the documents produced. The petitioners have relied upon (i) the bye-law of the Juma-ath approved in 1988, (ii) the letter

- dated 03.12.2024 issued by the Secretary of the 1st respondent to the 1st petitioner, and (iii) the letter dated 04.01.2025 issued by the Committee to the 2nd petitioner. The respondents rely on (i) the audit report and financial statement for the period 25.11.2020 to 13.04.2024, (ii) the Observer's report dated 13.02.2025, (iii) the Panchayath notice dated 21.01.2025, (iv) the complaint dated 03.03.2025 filed before the Divisional Waqf Officer, and (v) the notices dated 20.11.2024 issued to the petitioners, as well as (vi) the Monitoring Committee report dated 26.02.2025.
- 4. The primary question that arises for consideration is whether the suspension of the petitioners from the Jama-ath and the other decisions alleged to have been taken by the 1st respondent Committee are in conformity with the governing bye-law of 1988. The petitioners contend that no General Body meeting was convened prior to the suspension and that the Committee acted unilaterally, in violation of the mandatory procedure. On examining the materials placed on record, it is seen that the respondents have not produced any document showing that a General Body meeting was called or that the petitioners were given an opportunity to present their defense before disciplinary action was initiated. In the absence of such material, and in light of the admitted fact that the suspension was communicated through letters dated 03.12.2024 and 04.01.2025, the Board finds merit in the contention that the suspension was effected without adherence to the bye-law. The interim order passed in I.A. No. 43/2025 staying the suspension was therefore justified and calls for confirmation.
- 5. As regards the allegations raised by the respondents concerning financial irregularities, the audit report submitted by Jeeson & Company and the reports of the Observer and Monitoring Committee

- do indicate serious discrepancies requiring verification. While the petitioners dispute the correctness of these findings, it is not possible for the Board to record a final conclusion on the issue solely on the basis of the documents produced, especially since no oral evidence has been adduced by either side. Nonetheless, the nature of the discrepancies reported warrants a statutory inquiry under Section 32 to ascertain whether any misappropriation or malpractice occurred during the petitioners' tenure.
- 6. At the same time, the materials placed on record are insufficient to grant the prayer of the petitioners seeking prosecution against the present Committee, as no prima facie evidence of mala fide actions or willful misconduct by the present Committee has been established, apart from the procedural irregularity relating to the suspension. The relief seeking a direction to convene a General Body meeting under the supervision of an Observer also does not arise at this stage, since the dispute pertains primarily to disciplinary proceedings and financial accountability, and not to any election or structural breakdown within the Jama-ath.
- 7. In view of the above discussion, the suspension of the petitioners by the 1st respondent Committee is found to be in violation of the byelaw, and the interim order staying such suspension is hereby made absolute. The prayer for reinstatement of membership thus stands allowed. As to the allegations of financial misconduct raised by the respondents, the matter requires a detailed fact-finding inquiry. The Divisional Waqf Officer, Thrissur, is therefore directed to conduct an inquiry under Section 32 into the accounts and administration of the Juma-ath for the period 2019–2024, including verification of the audit report, vouchers, receipts, and construction-related transactions, after

affording both sides an opportunity to present their version. The petitioners shall cooperate fully in the inquiry and produce all relevant documents in their possession. The Divisional Waqf Officer shall submit a detailed report within sixty days.

- 8. In light of the pendency of the statutory inquiry, the prayer for prosecution of either party is premature and is deferred until completion of the inquiry. Both parties are directed to maintain peace and refrain from actions that may disturb the functioning of the Waqf. The O.P. is disposed of as above

The petitioners have filed this O.P. challenging Ext. P1 notice dated 06-06-2024 and Ext. P2 and Ext. P3 notices dated 02-10-2024, issued by the 1st respondent Jama-ath and its office bearers, by which the petitioners were removed from the Managing Committee for different period and the 1st petitioner was further disqualified from contesting for the next two terms (six years).

The case of the petitioners is that the impugned decisions were taken without issuing any show cause notice, without granting an opportunity of hearing, without disclosing any specific charges, in a Committee/General Council meeting held without quorum, in violation of the registered Byelaw of the Jama-ath, and by manipulating the minutes by obtaining signatures after the meeting for the purpose of creating quorum.

It is also stated that the allegation relating to the so-called "unislamic marriage" is not a ground under the Byelaw to impose any disciplinary action and that the 1st petitioner has been subjected to repeated punishments on the same allegation without authority.

Despite service of notice from this Board, the respondents did not appear and did not file any counter. Hence, the matter is proceeded with ex parte. The Board had already passed an interim order dated 09/10/2024 in I.A. No. 331/2024, directing respondents 1 to 3 not to implement the

decisions taken as per Ext. P1 to Ext. P3 until further orders.

After carefully examining the petition, documents and the Byelaw of the Jama-ath, this Board finds that the decisions were taken in violation of principles of natural justice, mandatory procedures prescribed in the Byelaw were not followed, the meeting in which the decisions were allegedly taken did not have the required quorum, and the Managing Committee/General Council has no authority to impose such punishments without following the statutory procedure under the Waqf Act and the Byelaw.

The decisions taken by the respondents as per Ext. P1, Ext. P2 and Ext. P3 are set aside finding illegal, void and not sustainable in law. Respondents are hereby restrained from taking any disciplinary action or removal proceedings against the petitioners in future on the same or similar grounds, without strictly following the provisions of the Byelaw and the Waqf Act.
