Petitioners had raised several allegations against the respondents with regard to the administration and financial mismanagement of the waqf by the respondents. The respondents submitted counter stating that none of the ingredients which arrents interference of board under section 63 of the waqf act is attracted in this case. Prior to the election of the present committee in the year

2022 the waqf was administered by an interim mutawalli appointed by the board who had conducted election and the present committee to charge. Board had dismissed the petition on the findings that invoking power of the board under section 63 of the waqf act,1995 is not attracted as the allegations pointed out is not sufficient to appoint an interim mutawalli invoking powers conferred under section 63 of the waqf act,1995. The petitioners failed to convince the board the circumstances which warrants appointment of interim mutawalli.

The powers of the waqf board to appoint an interim mutawalli or to remove members of a waqf managing committee are derived from section 63 of the waqf act, 1995, which permits such intervention only upon sufficient proof of mismanagement, negligence, misconduct, or failure in the performance of waqf duties. The committee which is arrayed as respondent came into office following an election held on 25/09/2022, which was conducted under the supervision of the previously appointed interim mutawalli. As their term is already expired election was again conducted and the newly elected committee is in charge. The petitioners have not produced any conclusive or new evidence of financial irregularities or gross mismanagement committed by the newly elected committee which could justify intervention under section 63. Hence, the relief sought for removal of the committee has become infructuous.

	With respect to the petitioners' prayer to take action based on
	the audit reports for the years 2012-13 to 2017-18, it is recorded
	that the waqf act, 1995, clearly stipulates the procedures and
	consequences relating to audit findings. If any actionable issues are
	disclosed, appropriate steps shall be taken from the administrative
	side of the board, in accordance with the provisions of the act and
	the rules made there under. It is therefore held that any further steps
	pursuant to the audit reports must be initiated and dealt with by the
	administrative wing of the board, in accordance with the statute,
	and not as part of these enquiry proceedings.Further the office shall
