Order passed vide separate sheet on the basis of mediation talks.</p> <p>This Original Petition is filed by the petitioners, father and son, under Sections 32, 46, 70 and 71 of the Waqf Act, 1995 invoking the supervisory jurisdiction of this Board in respect of Waqf No. 4010/BRA – Vellikulangara Muhiyudheen Town Juma Masjid.</p> <p>The case of the petitioners is that the second petitioner was a B-class member of the Jama-ath attached to the said Masjid and that the first petitioner, father of the second petitioner, was formerly the President of the Jama-ath. According to them, the Jama-ath earlier had two classes of membership, namely A-class and B-class. A-class membership was assigned to the head of the family residing in the family house, while married children residing along with parents were treated as B-class members. The second petitioner became a B-class member after his marriage.</p> <p>It is alleged that his subscription was abruptly discontinued and when he attempted to remit the subscription through money order, the same was refused by the respondents. It is further alleged that he was informed that he was not entitled to any rights or benefits available to members of the Jama-ath. The petitioners therefore approached this Board seeking declaration of membership rights, direction to accept subscription, extension of all services, and other consequential reliefs.</p>

Earlier, in IA No. 137/2020-25 filed in this OP, this Board had passed an interim order directing the respondents to permit the children of the second petitioner to attend the Madrasa attached to the Masjid and further directed that no act shall be committed curtailing the religious and human rights of the petitioners.

The respondents entered appearance and filed counter statement as well as a petition to vacate the interim order. They denied the allegations and contended that the first petitioner, who was an A-class member, voluntarily relinquished his membership and obtained transfer certificate, and as per the by-law of the Jama-ath, when an A-class member relinquishes membership, the B-class membership of his family members automatically ceases. It is further submitted that presently the Jama-ath follows a single-class membership system and any person seeking membership must submit application and remit the prescribed fee and decision in this regard is taken by the General body.

The matter was posted for mediation on 24.02.2026. Both parties appeared. During mediation, the issue relating to admission of the children of the second petitioner in the Madrasa was discussed. Initially, objection was raised regarding age; however, upon production of age certificate, the committee agreed to permit the child in the Madrassa. The committee further submitted that they are ready to provide services as directed by the Board.

With regard to membership, the respondents admitted that the first petitioner was an A-class member and that the second petitioner was a B-class member. It was also submitted that the earlier classification has now been discontinued and there exists only a single class of membership applicable to all members. The respondents contended that fresh application is required for membership and that the matter would ordinarily be placed before the general body. The first petitioner submitted that the only surviving grievance is to secure membership for the second petitioner and that he is prepared to relinquish all other claims if

such membership is granted. The respondents stated that the matter requires discussion in the general body.

Upon consideration of the submissions and in view of the admitted fact that the second petitioner was earlier a recognized member of the Jama-ath, this Board finds that there is no necessity for further deliberation by the general body regarding restoration or grant of membership, particularly when the supervisory authority under Section 32 of the Act is empowered to ensure proper administration and prevent arbitrary exclusion of members.

In the result, and in terms of the settlement arrived at during mediation, the following directions are issued:

1. It is declared that the second petitioner is entitled to be granted membership to Vellikulangara Muhiyudheen Town Juma Masjid and to enjoy all rights and privileges attached to membership, subject to compliance with uniform procedural requirements applicable to all members.
2. The second petitioner shall submit an application for membership along with the requisite fee and subscription as applicable under the present system.
3. Upon receipt of such application and fee, the Jama-ath Committee shall grant membership to the second petitioner without unnecessary delay and shall not insist upon general body approval contrary to this order.
4. The respondents shall accept annual subscription from the second petitioner and extend to him and his family all services and benefits uniformly extended to other members of the Jama-ath.
5. The children of the second petitioner shall be permitted to attend the Madrasa attached to the Masjid subject to age and eligibility criteria uniformly applicable to all students and without discrimination.
6. The petitioners shall not be denied any religious or customary rights available to members of the Jama-ath solely on the basis of the earlier relinquishment of membership by the first
